Introduction

Geo Medtech Ventures S.à r.l. ("GEO") is a registered alternative investment manager pursuant to Article 3 of the Law dated 12 July 2013 relating to alternative investment fund managers, as amended from time to time (the "AIFM Law").

Object and purpose of the policy

The protection of the privacy and personal data processing of users who consult the GEO website are very important. GEO, understanding that the users are entrusting it with personal information, takes very seriously the obligation to protect and safeguard this information. This policy therefore illustrates the types of data collected during your use of the website, the purpose for which it is collected, the way in which it is processed, the persons to whom it might be transmitted, and the security measures implemented to protect it.

This policy is applicable to any data acquired by GEO as a result of your consultation of its websites. This does not apply to any website controlled by third parties unrelated to GEO that you may access through links from the GEO site.

Data processed

During the consultation of the GEO website, our server automatically records some information related to this usage (for example, your IP address, the website from which you arrived at our site, and including the date and the duration of the connection).

In addition, we collect the personal data you provide to us; for example, personal data entered by the user (name, gender, address, e-mail address, telephone/fax number) on a registration page.

Purpose of data processing

GEO could use personal data:

- for the administration of clients and users;
- to inform customers about its products and services;
- for use in general or personalized marketing campaigns;
- for the further development of digital channels;
- to comply with legal and security obligations;
- for other purposes referred to in the use of certain products and services.

GEO respects all current laws and regulations regarding the use of personal data.

Transmission of data on the use of electronic services

Your data is not used by GEO for purposes other than those described above. The data on the usage of the websites may be shared with third parties where permitted by law, if GEO is required to do so or if data transmission is necessary to enforce our rights, in particular in the event of a dispute relating to a contractual relationship. In addition, GEO can disclose your information to service providers, indicating that they should use it only for the purpose for which it is provided. All individuals and entities who may receive data must comply with the applicable international and national laws on data protection, as well as with the data protection norms of GEO.



Security measures

GEO has adopted reasonable technical and organizational security measures in order to protect personal data collected through the websites from unauthorized access, misuse, loss or destruction, taking into account the applicable legal and regulatory requirements.

Transmission of data via the internet

Generally speaking, the Internet is not regarded as a secure environment, and information sent via the Internet can be viewed by unauthorized third parties, with a potential risk of disclosures, alterations in content and technical issues.
